





Stigma describes the negative perceptions commonly associated with individuals with substance use disorders. Stigma can be a powerful barrier that prevents those suffering from addiction from accessing treatment.



# PRIMARY DRUG FOR PEOPLE ADMITTED FOR TREATMENT THROUGH COCA FUNDING



The above chart shows the primary drug of use for individuals admitted for treatment through COCA funding. As our nation continues to struggle with the opioid epidemic, it is clear from the data above that people in Berks County are suffering from opioid use disorders at an alarming rate. Historically, alcohol as the primary drug has always been significantly higher than any other drug. However, in fiscal year 2014/15, opioids emerged as the highest primary drug of choice, marking the first time in the 40 year history of COCA that alcohol has not been ranked highest as the primary drug of choice. Additionally, over the past four years the number of people reporting K2 and methamphetamine as primary drugs of choice has continued to rise.

#### WHAT IS TASC?

TASC is a drug and alcohol central intake and treatment referral agency licensed by the PA Department of Drug and Alcohol Programs. COCA contracts with TASC to provide drug and alcohol assessment, treatment referral and recovery support services for Berks County individuals in need of public funds for addiction services.


