





PRIMARY DRUG FOR PEOPLE ADMITTED FOR TREATMENT THROUGH COCA FUNDING

This chart shows the primary drug of use for individuals admitted for treatment through COCA funding during fiscal year 19/20. It is clear from the data that people in Berks County continue to struggling with opioid use disorders at an alarming rate. This year also saw a slight increase in alcohol and methamphetamine as primary drugs of choice.

RECOVERY

HACIA ADELANTE

INDIVIDUALS SERVED: 23

In 2015, YMCA case manager Leroy Cruz started talking about a problem that he was trying to solve. Individuals who spoke Spanish as their sole language had nowhere to go for recovery housing. There were women in prison who could not be released because there was no program that could accept them. The YMCA had taken several clients who did not speak English, but Leroy noticed that even though he could provide them with case management, they continued to struggle. YMCA residents live in communities, which provides support for many. But when you cannot communicate with those that you live with, it is an isolating experience. Reading needed a program where people who are Spanish-speaking can live together and support each other in their recovery from substance use disorder. Eventually, Leroy started talking about this problem with anyone who would listen. When he spoke to George Vogel at COCA, George didn't just listen, he took action. With funding from COCA and the United Way, Leroy's vision came to life in December 2017 in the Hacia Adelante program. Hacia Adelante means "Moving Forward" in English and that is exactly what the residents are doing. Participants in the 8 bed program live at the YMCA and receive case management to help them achieve their goals. They attend counseling, mutual aid meetings, obtain employment, attend ESL classes, and learn life skills.
