WHAT IS COCA?

Since 1971, the Council on Chemical Abuse (COCA) has served in a lead role, offering the resources necessary to respond to the complex problems of substance abuse and addiction. Designated by the County Commissioners as the Single County Authority (SCA) for Berks County, COCA is a non-profit organization responsible for the administration and management of publicly-funded alcohol, tobacco, and drug services.

MISSION

To provide leadership in the development and implementation of policies and programs related to a system of prevention and intervention services that prevent the onset of addiction, and treatment services that promote recovery.

"Our mission has always been about ensuring services are provided using high quality programming" For over 50 years the Council on Chemical Abuse (COCA), as the Single County Authority for drug and alcohol programs, has been providing drug and alcohol Prevention, Intervention, Treatment and Recovery Support services to Berks County. Our mission has always been about ensuring these services are provided using high quality programming.

During fiscal year 2023/24, COCA continued to provide evidence-based Prevention programs to schools and the community, and summer programs for youth. During the past fiscal year, the Department of Drug and Alcohol Programs approved Teens and Technology, a protocol developed by COCA Prevention staff, as a program available statewide.

COCA has expanded Intervention efforts to include best practices in harm reduction. This includes distributing naloxone, a medication that can reverse opioid overdoses,

to first responders, community members and organizations, and instituting a naloxone redistribute program enabling organizations to offer naloxone directly to their clients. Our harm reduction efforts also include distributing fentanyl and xylazine drug checking strips and offering harm reduction trainings.

COCA continues to offer a comprehensive continuum of drug and alcohol treatment services including all FDA approved medications for opioid use disorder. We also continue to provide recovery support services including recovery housing and individual recovery support services. During FY 23-24, recovery housing beds for Women with Children were increased.

As this year's annual report demonstrates, COCA continues to provide high quality services to the people of Berks County.

OPIOID SETTLEMENT FUNDS

In close conjunction with the County of Berks, COCA continues to manage the Berks County Opioid Settlement Funds (OSF). These monies are a significant benefit to the county, because they support new and innovative services, and bolster previously underfunded programs. All OSF monies must be used to abate opioid use and related disorders, and must be spent in accordance with the National Opioid Settlement agreement. What's more, every subsidized program is reviewed by the PA Opioid Misuse and Addiction Abatement Trust.

OSF monies are crucial to enhancing much needed treatment and support services offered to Berks County residents, including but not limited to: medication assisted treatment, residential and outpatient treatment services, expanded recovery support services to pregnant and post-partum women and recovery house residents, as well as services to the community in general. Among the most significant programs supported by OSF in FY

2023/24, is a comprehensive medication assisted treatment program at Berks County Jail, which includes full medical and social service support.

Undoubtedly, the most exciting aspect of OSF is the capacity to adopt new services that were previously unable be funded.

These include a workforce development program for those in early recovery from an opioid use disorder, transportation for those lacking the ability to attend much needed treatment and support services, and specialized equine therapy for post-partum women. In addition, several programs providing family support and education have been implemented. Finally, resources are now available to help inform the English and Spanish speaking communities about various opioid/overdose issues and the local resources to address these issues.

SOS BERKS OPIOID COALITION





Since 2016, COCA has helped lead the SOS Berks Opioid Coalition, which works to reduce opioid overdose deaths in Berks County. Among the projects undertaken in the 2023/24 fiscal year are:

- The SOS Berks Mural Project Two recoverythemed murals were dedicated in Reading.
 The first (pictured top left), was dedicated in
 September on 9th & Oley Sts. It depicts the
 recovery journey of Jose Lugo, who credits
 his recovery to his family and Puerto Rican
 heritage. The 2nd, (top right) on 11th and
 Richmond Sts, features inspiring words from
 Yvonne Stroman. Both were based on stories
 from SOS Berks stigma reduction campaign,
 Addiction Doesn't Define Me.
- ♣ Recovery Simulation Events SOS Berks hosted two Recovery Simulation events, engaging about 80 people in each. These hands-on experiences help participants better understand the challenges faced by those in early recovery.

- ↑ The Response Magazine Published the Response Magazine, with information about innovations in local efforts to address substance use disorder in Berks County,
- Health to Go Vending Machine SOS partnered with Penn State College of Medicine and the Reading YMCA to introduce a new smart vending machine that dispenses free wellness and harm reduction supplies, and connects people to social services in the community.
- tuncheon for African American leaders After learning that African Americans are
 disproportionately impacted by overdoses in
 Berks County, but less likely to seek treatment,
 SOS Berks hosted a luncheon, engaging 20
 community leaders in a conversation on how to
 reverse that trend.





Our Kids/Teens & Technology programs educate students on responsible digital citizenship, teaching them how to create safe spaces online, evaluate information accuracy, and most importantly, the skills to create a balance between media time and other life activities. Students also learn how gaming is connected to gambling, and how developers use behavioral science to keep people gaming, as well as the warning signs of a technology addiction. In January 2024, PA's Department of Drug and Alcohol Programs. listed Kids/Teens & Technology as an approved program for other SCAs to receive funding to facilitate. We are proud that our technology programs are now being delivered across the state.

Youth Leadership Council

People Reached: 113

Last September, COCA launched the Youth Leadership Council (YLC) in order to offer Berks County high school youth the opportunity to represent their peers as the youth voice for prevention. In FY 2023-24, YLC members participated in various projects and events including a Halloween Trunk or Treat, Day at the Capitol, and a clothing drive. YLC member Katelynn Humbles (pictured above, far right) was also awarded the \$5,000 Pat Ganter Scholarship for 2024 in May.



Tobacco Cessation Classes

People Reached: 741*

COCA's tobacco cessation classes give
Berks County residents the resources
and support they need to quit nicotine
products. Taught by Tobacco Treatment
Specialist Teresa Detweiler, classes are
cost-free and judgment-free. Participants
meet in hour-long weekly sessions over
7-8 weeks, either in person or virtually, and
receive free nicotine replacement products,
as well as advice for fighting cravings. In
addition, Teresa follows up with phone calls,
providing participants with encouragement,
and offering words of support as they work
towards their goal of being nicotine-free.

Stigma & Harm Reduction

Drug checking strips distributed: 14,247

COCA continues to implement innovative approaches to expand harm reduction and reduce stigma. In FY 2023/24, Penn State College of Medicine introduced the new Health to Go smart vending machine, in collaboration with SOS Berks and the Reading Berks YMCA. The machine dispenses free harm reduction items, including NARCAN® and drug checking strips, alongside other wellness supplies such as hygiene kits and menstrual supplies. The machine's touch screen front enables people to find community services or learn more about the items they select. In addition, COCA produced short videos in English and Spanish that instruct people on how to use fentanyl and xylazine checking strips. These videos can be viewed on the vending machine. By making harm reduction supplies available in a public space along with other wellness items, we increased their accessibility, while simultaneously presenting them to the general public in a nonstigmatizing manner.



NARCAN® Expiration Campaign

In July, we launched a multimedia campaign that reminded people to check the expiration dates on NARCAN®. This bilingual campaign included digital ads on Facebook and Instagram, as well as print ads and radio spots in English and Spanish. In addition, the ads appeared on Reading BARTA buses to ensure maximum exposure. All ads directed Berks County residents to our website to order a free box of NARCAN® as a replacement, or a NARCAN® kit for those who did not previously own one.





We produced short videos in English and Spanish that taught people how to use drug checking strips to check street drugs for fentanyl and xylazine.

NARCAN® Distribution

Narcan kits distributed: 7,841


At the Council on Chemical Abuse, we know that naloxone is integral to preventing overdose deaths and saving lives. We are committed to getting free naloxone medication into as many hands as possible in Berks County. NARCAN® is a brand name of naloxone formulated in a nasal spray to offer quick and easy administration, reversing the effects of an opioid overdose in minutes.

COCA distributed a total of 7,850 NARCAN® kits in FY 2023/24, more than doubling the 2,703 total from the previous fiscal year.

This increase is the result of several factors. including greater awareness and reduced stigma among the general public. In addition, COCA implemented a media campaign focused on the availability of NARCAN®. (See article on left) We could not have been as successful with NARCAN® distribution without making connections and collaborating with partners in the community. We have providers, agencies, and outreach organizations that redistribute NARCAN® to their clients, patients, members, and the community at large. We also have businesses, offices, schools, and churches requesting NARCAN® for their staff and congregations. In addition, law enforcement, emergency response personnel, search and rescue, and canine teams stay prepared by having NARCAN® kits on hand.

In addition to providing free NARCAN®, COCA also offers free training, presentations, and support to any person, group, or business seeking resources. We continuously work to increase awareness, provide access, and decrease stigma surrounding NARCAN®, and to educate people on its effectiveness as a lifesaving tool that should be in every first aid kit and AED box.

Treatment Services

Individuals Funded for Treatment: 1,269

In the course of treatment, an individual may require admission to several levels of care (i.e. detoxification followed by residential treatment). A total of 1,269 individuals were funded for 1,459 treatment episodes in fiscal year 2023/24, 312 episodes were for residential levels of care (i.e. withdrawal management, residential treatment and halfway house) and 1,147 episodes were for outpatient levels of care (i.e. intensive outpatient, partial hospitalization and medication-assisted treatment).

Treatment Access

Requests to COCA: 2,338

When an individual requests access to treatment, screening/assessment is completed to determine the person's need for substance use disorder treatment and their eligibility for COCA treatment funding. Berks County residents with a substance use disorder and no public or private insurance benefits are eligible for COCA treatment funding.

RISE RECOVERY CENTER

The RISE Center opened in 2019 as a place to provide resources, support, activities and meeting space for people in recovery and their families. Over the past few years, under the direction of COCA Community Programs Specialist Yvonne Stroman, the number of activities occurring at the RISE Center have greatly increased. In FY 2023/24, a variety of recovery groups held meetings at RISE. COCA also hosted 7 DDAP professional trainings there, attended by 185 people. And, perhaps most significantly, activities such as Taco Tuesdays, football watch parties, movie nights and Sundaes on Fridays, helped support people in recovery by providing them with opportunities to meet, socialize and have fun.

SOR Housing Program

Individuals/Families who Received Services: 57

The State Opioid Response (SOR) Rental Assistance Program was able to provide rental assistance, utility assistance, as well as furnishings from the Rudden Family Foundation, to 57 individuals and families in fiscal year 2023/24. All individuals worked with a case manager and competed a housing service plan and household budget. Clients were also linked with community resources, such as food and diaper banks, utility assistance programs, free/low-cost internet, and employment programs.

Certified Recovery Specialist Training

Participants: 48

COCA offered three Certified Recovery Specialist (CRS) training cohorts in FY 2023/24, which were completed by 48 participants. The cohorts consist of 10 sessions held on Saturdays at the RISE Center. Once completed, participants must pass a PA Certification Board exam to earn the CRS credential, which qualifies individuals in recovery to help others move into and through the recovery process. The cohorts are usually filled to capacity and often have a waiting list. The CRS trainings offer a career path for people in recovery that enables them to serve as a role model, mentor and advocate for those in early recovery, and to provide a service that substantially improves an individual's ability to sustain recovery.








